## **GOOD NEWS! TENTATIVE AGREEMENT REACHED**

The Collective Agreement between CUPE and Manitoba Liquor and Lotteries expired on September 30, 2015.

Based on member survey results your Bargaining Committee prioritized:

- Wage increases and equity
- Equity in hours of work
- DLT and benefits improvements
- Recognition of long service

Opportunities for promotion and respect for seniority, issues with the use of casuals and filling of vacancies.

The Union has met with the Employer for ten days to bargain, and reached a tentative agreement. At general membership meeting scheduled for **\*\*January 13 and 14, 2016**\*\*, members will be asked to VOTE for an agreement that includes:

- No concessions
- 4-year term
- Total of 2% wage increases in each year of the agreement, with retroactivity to October 1, 2015
- Additional DLT entitlement of 24 hours upon ratification, DLT entitlement increase to 80 hours each year (April 1, 2016, 2017, 2018, 2019), DLT bank maximum increases to 400
- Option for 36.75 hour workweek at same hourly rate of pay
- Vacation improvement for new employees
- Standby pay improvements
- Benefits improvements, including retirees' health spending account
- Better language on human rights and health and safety
- MBLL continues to pay LGA registration fees
- Agreement to discuss utilization of casual employees
- Agreement to deal with merger and pay structure, including green circling.
